You **must** register Disclosable Pecuniary Interests and are recommended to register 'Other interests' by providing written notification to the City Council's Monitoring Officer of the details required as set out in this form.

1. If your circumstances change, provide written notification to the Monitoring Officer of that change, within 28 days of becoming aware of any changes to the interests specified above.
2. If you are present at a meeting of the authority or of any committee, sub committee, joint committee or joint sub-committee of the authority and have a Disclosable Pecuniary Interest in any matter to be considered or being considered, at the meeting and, if the interest is not entered in the Authority's register, you must disclose the interest to the meeting. For more information about what to do at a meeting please consult your Parish or Town Clerk.

If the interest is not entered in the Authority's register and is not the subject of a pending notification you must notify the Authority's Monitoring Officer of the interest before the end of 28 days beginning with the date of the disclosure.

You should do this by submitting a new registration form as soon as possible.

3. Part 1 of this form contains Disclosable Pecuniary Interests as prescribed by The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012. Part 2 contains 'Other' interests. To enable Members to register interests which constitute Personal Interests and to promote openness, Members are recommended to complete this section.
4. Disclosable Pecuniary Interests include not only a Members' interests but also the interests of a spouse or civil partner. In the notice below 'my spouse or partner' means anyone who meets the definition in the Localism Act, i.e. my spouse or civil partner, or a person with whom I am living as husband or wife or a person with whom I am living as if we are civil partners, and I am aware that that person has the interest.
5. The Localism Act 2011 created specific criminal offences in relation to the disclosure of Pecuniary Interests:
 - Failure to declare a DPI within 28 days of taking office
 - Failure to disclose unregistered DPI at a meeting
 - Failure to tell Monitoring Officer (with 28 days) an unregistered DPI had been declared
 - Participating or voting at a meeting where you have an DPI
 - Providing knowingly or recklessly incorrect information
6. If the nature of the interest is such that the Member or co-opted member, and the Authority's Monitoring Officer, consider that disclosure of the details of the interest could lead to the member or co-opted member, or a person connected with the Member or co-opted member, being subject to violence or intimidation, any published version of the register must not include details of the interest (but may state that the Member or co-opted member has an interest, the details of which are withheld (under section 32 (2) Localism Act 2011)).
7. You must, within 28 days of receipt, notify the Monitoring Officer in writing (using the form at Section 3) of any gift, benefit or hospitality with a value in excess of £50 which you have accepted as a Member from any person or body other than the Authority.
