To change the layout and design of the premises in accordance with the submitted plan, drawing number 2857-60. **The main changes include relocation of the bar servery to first floor, addition of stage, and amendments to the fixed seating.**

To extend the hours for the sale of alcohol, live music, recorded music and anything of a similar description **until 02.00 hours Sunday to Wednesday, and 03.00 hours Friday and Saturday** (currently permitted until 01.30 Sun to Wed, 02.00 Fri and Sat)

To extend the provision of late night refreshment **until 02.00 hours Sunday to Wednesday, and 03.00 hours Friday and Saturday** (currently permitted until 01.30 Sun to Wed, and 02.00 Fri and Sat).

To permit all activities on New Year's Eve until 03.00 New Year's Day.

To extend the opening hours of the premises until 02.30 Sunday to Wednesday and 03.30 Friday and Saturday (current permitted until 02.00 Sun to Wed, and 02.30 Fri and Sat)

To remove the following conditions from the premises licence:
When dancing is to take place on the premises in an area not previously approved for dancing by the Authority, at least 14 days notice must be given to Environmental Health and Regulatory Services (Health Protection Service) and the Licensing Authority, identifying the area to be used which should be suitable and adequate in size as the designated dance floor for the intended use, and dancing must not take place in that area unless approved by the authority.

Soft drinks and non alcoholic drinks will be available. (mandatory condition)

A recognised proof of age policy to be enforced. (mandatory condition)

There shall be no live music in the upper room.

Music in the upper room shall only be played at background levels.

PEL

1. Capacity The number of members of the public who may be present at any one time on the premises or in any part of such premises specified below shall not exceed:-
Ground Floor - 200. (This should be covered off by the FRA)

To add the following conditions to the premises licence:

1. A Challenge 21 policy shall operate in the premises in relation to the sale of alcohol.

2. All staff shall be aware of the law regarding the refusal of service to any person who is drunk or is underage and shall be aware of how to seek ID from anyone who appears to be underage.

3. Live music shall not be played on the first floor past 00.00 hours on any day.
