Allocation of the site for housing needs to consider the likelihood for any prejudicial impact of housing on the existing sports facilities and playing fields if mitigation is required it should be provided at the developers expense as part of the planning proposal. There is potential for nuisance on residential

developments in this area close to the multi use games area (which is floodlit) and sports pitches. The impact of development on the playing field and sports facilities needs to be considered in respect of paragraphs 99 and 187 of the NPPF.
