Statement 3.21. New development and the redevelopment of sites may provide opportunities to extract minerals before construction commences. A number of surface minerals, such as building stone, are present across Sheffield, although there

has been no recent working of any of these resources. It is likely that there

will be few (if any) applications for mineral extraction across the duration of the Plan.

Sheffield Area Geology Trust (SAGT) suggest Statement 3.21 is unsound because the statement does not suggest include the value of sites developed to extract surface minerals as potentially invaluable sources of scientific .geological knowledge.

Exposure of surface minerals by new development or redevelopment, however temporary, is likely to offer opportunity for the scientific examination of geology not previously revealed, which may result in new knowledge and a greater understanding of geological interest and assets elsewhere within the city and the region, or at a national or international level. Acceptable plans for extraction of surface minerals should include access by geoscientists with local expertise to conduct an appropriate survey before restoration work is commenced. Including such a condition for development would accord with Policy GS8.

If the statement and associated policy ES7 were to include minor amendments that set the opportunity to records the geology at new development sites to extract surface minerals before construction commences as a condition of such developments being permitted, then SAGT would consider the plan in this respect sound

Sheffield Area Geology Trust (SAGT) welcomes inclusion of Geodiversity in the Local Development Plan and, in general, we support this policy, but suggest it is unsound because statement 8.29 and and policy GS8, as worded in the plan, gives the misleading impression that geodiversity and geo-conservation is of lesser value than 'heritage' (i.e old building) conservation, as it prioritises stone extraction for heritage purposes over any geo-conservation issues.

There are cases where new extraction of stone can be potentially damaging. If a potential stone extraction site contains features of significant local, regional or national geological interest, it is possible that indiscriminate and uninformed extraction could destroy such features. In such cases, a balanced assessment should be undertaken. In many cases this may not prohibit the extraction of stone, but an assessment would likely identify and delimit more exactly particular locations within sites where extraction would not be likely to cause any irreversible damage or compromise the geological interest.

If such an geological assessment were, through minor amendment, to be included within statement 8.29 and as a condition of the policy GS8, then SAGT would consider the plan, in this respect, to be sound.

Acceptable plans for extraction of surface minerals should include access by geoscientists with local expertise to conduct an appropriate survey before restoration work is commenced. SAGT suggest the following minor amendment as an insertion to Policy ES7 (given here in "quotation marks"):

Where a site is likely to have surface mineral resources, applicants should investigate the economic potential of the site for extraction of these resources before development. Extraction of non-fossil fuel mineral resources w.ill be permitted where it is practicable, "where it includes opportunity to record the geology", where it would not have unacceptable environmental impacts and where appropriate plans are made for the restoration of the site.
