While welcoming the preparation of a Local Plan for Sheffield, SCAG was concerned that although the city's heritage are referred to in passing within the plan, there is no general statement of the significance of the richness of Sheffield's heritage in the built and natural environments for the city's distinctiveness and its economy.

Please set out the modification(s) you consider necessary to make the Local Plan legally compliant and sound, in respect of any legal compliance or soundness matters you have identified above:

SCAG make the following observations in detail about the ways in which the Local Plan might be modified:

- Heritage Character There was a failure to recognise the heritage and value of waterways and biodiversity and the possibility of conflict between GS policies and the protection of waterways. The mention of water-powered sites and of Sheffield metal trades buildings, some of which are unique to Sheffield, should be made more explicit. A consideration of the appropriateness of a suggested use for metal trade buildings should be included.
- Areas of Special Character These are protected in the existing Plan but have disappeared in the new draft Plan. It is imiportant to recognise that the identification of areas for protection is an ongoing process and areas that might be suitable for future designation as Conservation Areas should be indicated within the Local Plan.
- Tall Buildings There should be some reference to how sustainability can be achieved in the development of tall buildings. Tall building zones should be identified. The reference to a tall building on Milton Street as a gateway structure needs more explanation.
- Sustainability This should be included as one of the tests of soundness.
- Local Heritage List A paragraph on this should be included and a policy statement developed
