There is no mention of improving the active trave provision in terms of cycle parking except where there is a "development". I live in Woodseats and there is unlikely to be any developments on the main shopping street. In Woodseats we live with a very

busy thriving centre, cut through the middle with a main road. Most people who shop there come on foot. If there was cycle parking more people might be prepared to ride, so reducing the congestion. For all the people who are walking, there is a lot that could be done to improve the street. A few trees would make a lot of difference.
