The Local plan is not sound in so far as it will not deliver in line with the requirements for implementation of the South Yorkshire Combined Mayoral Authority Energy Strategy (Version: 2 01.01.2022). The latter sets policy targets to reach net zero carbon by 2040 - which notably is 10 years behind Sheffield City Councils' declared aim of becoming a zero-carbon city by the start of the 2030's. Specifically, the SYCMA's Energy strategy policy target of "no new homes using fossil fuel by 2025" in inconsistent with the Local Plan POLICY ES1: MEASURES REQUIRED TO ACHIEVE REDUCED CARBON EMISSIONS IN NEW DEVELOPMENT (Developments that result in new dwellings or new non-residential buildings will be

expected to reduce their carbon emissions by at least 75% from 1 January 2025 and be net zero carbon from 1 January 2030).

Furthermore, there are other areas where alignment of the Sheffield Local Plan with the higher regional energy strategy is not evident. For instance, in the area of renewable energy networks; there is no obvious foresight reference in the Local Plan to ensuring the ability at a future time to utilise potential abandoned coal mines for use as heat storage, their connection to shared energy networks, and how this would integrate into plans for specific areas where a decarbonised 'gas' network is not present.

It appears to me, as a lay person, that the Local Plan fails to comply with the duty to cooperate, as it is not consistent with the Energy Strategy for a relevant authority – the SYMCA.

I submit that the Local Plan needs to be amended to ensure that it addresses the urgent need to respond to the Climate Emergency, is consistent with SYMCA Energy Policy Target of no new homes using fossil fuel by 2025, and further extends this requirement to new non- residential buildings so Policy ES1 becomes "Developments that result in new dwellings or new non-residential buildings will be expected to be net zero carbon from 1 January 2025".
