St Ann's Court

Becton centre

Existing Halfway travellers site

Each of these has a negative impact on the residential area such as:

Traffic congestion

Air pollution

Litter from the ever increasing number of fast food takeaway around Crystal Peaks. Queues at tip backing up onto the roundabout

Queues at drive throughs, including the soon to be Burger King onto the roundabout High level of fly tipping due to frustrations queuing for tip
