I came to Sheffield to live and work in 1968. Since then I have been involved in various ways in the Broomhill Action Group (BANG), the Friends of the Porter Valley, Portland Works, Loxley Cemetery, Rivelin Valley Conservation Group. As a journalist on the Morning Telegraph I became aware of the lack of interest in heritage matters among councillors and, as a result, officers. Humphrey Nowill and others from the Council for the Conservation of Sheffield Antiquities worked to prevent Abbeydale Industrial Hamlet completely disintegrating. A small group of theatre-lovers agitated to prevent the Lyceum Theatre being demolished. All with little Council support at the time.

I was hoping the new Local Plan would re-set the Council's priorities with regard to heritage and put greater emphasis on protecting and creating Conservation Areas, Listed Buildings, Areas of Special Character, etc that make the city so special and unusual. But it does not do that.

The plan as proposed seriously undervalues Sheffield's 'heritage' buildings and other structures, including the small rivers that powered an industry with global reach, and as a result puts them at risk in the future. These policies reduce the attraction of living in the city and the attraction of visiting the city and thus strengthening the economy. They also undermine Sheffield's wider responsibilities for safeguarding social, cultural, architectural and landscape features that are important at least on a national scale and in some instances even more broadly.

Many of these features are currently supported and protected mainly by voluntary groups who give time, effort and money with little support or encouragement from the local authority. The current situation in this regard is bad enough and tests the resolve of those involved. To apparently further diminish the importance of the work of these groups and the type of projects in which they are involved would be a serious mistake and indeed cruel.
