- and strongly feel that it is not a suitable site as it is too close to a well developed residential area. The land behind Springwell Grove is green belt and is higher than the houses so therefore privacy for the residents and neighbours around the area would be compromised.
- 2. I am also very concerned about the noice level and pollution that it would create by having an industrial site on the grounds.

- 3. My other concern is the amount of traffic in and around our area. The network can not cope with the high volumes of traffic. The opening of the new Birger King will also cause extra stress on the network too!! It is busy at all times of the day and often at weekends we have to leave our car at home due to traffic in/out of crystal Peaks!
- 4. I am now very concerned how this will affect the house prices in my area. Both myself and my husband have worked hard to purchase our property and feel if the plans were to go ahead you would jeopardise our future plans should we wish to sell our property.
- 5. There is already a travellers site very close to Springwell estate at Holbrook which is less than 2 miles away. I feel very strongly that others sites should be considered. I feel we have not had appropriate time to object as we were not informed about the plans correctly and this has caused myself and my family a lot of stress.
