It is a huge relief that brownfield sites are to be developed rather than Green Bely, and that ancient woodland sites like Smithy Wood is more protected fro development. However some brownfield sites have become bio-diverse since allocation and need further protection. For example, the former Ski Village, where understory and trees have now grown up, further developments should take this increased wildlife-value habitat into consideration and any plans for development take this into account, allowing more corridors, too, for wildlife to cross the whole site.

Detailed plans to address this would need to consider corridors for wildlife between other parts of Parkwood Springs and the former ski village. This may also be true of other brownfield sites I am less familiar with.
