# **Stocksbridge Towns Fund Board Paper: 25 2024**

#### 1 & 2. Welcome, and confirmation of minutes and any matters arising

## 3 Programme update

3.1 The following outlines the headlines for the Towns Fund projects.

## **Phase 1 Projects**

- a. Community Hub Cost plan is funded and progressing to tender. Planning permission has now been granted.
- b. <u>Place-making project</u> (including new town square) Possible requirement for additional budget to deliver cost plan resulting from factory shop acquisition. Project to progress.
- c. <u>Parking and Wayfinding improvements</u> Budget savings achieved, further being sought however the project can progress. Consideration needed regarding future infrastructure if enforcement is needed.
- d. Precinct Shop frontage works Cost plan funded. Designs and cost options are in development. Separate brief note provided
- e. Hopper Bus project Funding issue with MCA resolved. Expression of interest to receive grant for operation of bus service is now live.
- f. Post 16 hub MoU agreed with Northern College. Project to progress when Hub building completed (funding ring-fenced)
- g. Oxley Park Improvements Work underway
- h. Grants to Sports Clubs Funding agreed and work underway.

**Note** - possible need for budget movement into place-making project from later phased projects to enable procurement.

**Note** – Expression of Interest (EoI) is live and has been provided to Community Transport operators.

# Projects phased for later in the Programme & under review

h. <u>Sport Hub</u> – Board members have met with the respective sports associations to discuss developing a confederation/ masterplan. Options to be discussed in the session – *Graham to lead* 

- I. 3G pitch Pre-app planning advise suggest that the school site faces a number of challenges. Bracken Moor seems most feasible however operation and ground condition not resolved.
- J. Trails and Tracks with Yorkshire Water at Underbank No progress made to-date

## 4. Review of Future Projects (Priority and Delivery Approaches)

#### 4.1 Rivers Project

4.2 The Steel Valley Project have approached the Board to ask if the Board can consider providing some match-funding to enable them to deliver the Little Don improvement project. There are other funding opportunities that Steel Valley believe could still fund the delivery of the project and are considering making funding applications.

#### 4.3 Sports Hub

4.4 Discussions regarding the location, the ownership of the 3G pitch and its delivery model have taken place. Further key factors to consider are who would have legal ownership/ liability and operate the facility, and the ground conditions. Third party funding also needs to be considered again during this period. Board members have held initial discussion with the group of sports clubs which also takes in to account the Sport's Pavilion project. The sports clubs having similar or overlapping infrastructure (for example, changing rooms and social space) that may not be optimised. Lead Board Member Graham Silverwood to update Board on discussions.

## 5. Parking Strategy for the High Street

Officers and Board members will shortly need to engage with high street stakeholders regarding the regeneration activity that is planned. Car parking will be a major topic. Board asked for Transport Officers to provide some outline options for consideration. Broadly there are two options. One is to accept the current provision and utilisation, accepting there are a significant amount of parking provision all around the High street (which is free of charge – some private is time limited) or propose a strategy that would drive behavioural change through enforcement and charging. Outline options are provided in the accompanying slide deck.

**Action** – Agree options and principles favoured by the Board to enable development of Strategy.

#### 6. Land acquisition

6.1 In order to secure the properties required the Council's Chief Property Officer needs to approve transactions once contracts with land owners are agreed, or commence with Compulsory Purchase if acquisitions cannot be agreed.

The properties the scheme requires follow:

- a. St Lukes agreed and publicised.
- b. Flat 5 An enhanced offer has been made and is under consideration. Arbitration offered not accepted. Decision required as to next steps.
- c. <u>Bridge Shop</u> Best and Final Offer made. Arbitration process offered if not accepted. Decision required on next steps.
- d. <u>Factory Shop</u> Offer accepted in principle and Heads of Terms in development. Owner has received pre-app advise about a 4-story development on the site and may seek to market this. If this is the case the argument maybe made that the valuation previously agreed with the Council does not now reflect this new development potential and the owner may seek an increased payment.
- e. Chemist Offer made to the owner is under consideration with no issues expected.
- f. Bargain Booze Agreed subject to committee approval. Council needs to work through issues with garage users

Tenants impacted:

- g. <u>Bridge Charity</u> Are concluding the lease to take possession of the Café on the high street and relocate.
- h. Pharmacist Discussions underway

**Action**: Decision needed by Board on next steps if negotiations fail.

## 7. Projects updates:

#### 7.1 Community Hub & Library relocation (Stocksbridge 519)

- 7.1.1 The procurement approach for the project was discussed at the Board's workshop in January. The discussion centred around the merits of SCC utilising YORbuild framework. RLB and SCC Capital team's recommendation to utilise this framework was acknowledged as being the best route. This has now been questioned by some Board members therefore this unfortunately has put a hold on progress. A separate note is provided. Contract prices are needed in June to synchronise with MCA Board meeting. Risk of disconnect if delayed which may I push contracting to October 2024.
- 7.1.2 Scheme been granted planning with only 3 public comments. Two objections received. One letter of support. No material planning concerns raised.
- 7.1.3 SCC is working with the Ikon church regarding establishing this location as the interim location for the Library service in time for the service to decant in the summer.

**Action**: Board are asked to confirm the recommendation to use YorBuild framework to enable tendering.

## 7.2 Place-making

- 7.2.1 The visuals for the new market square and an updated cost plan have been produced. It was expected that the scheme would have been presented to SCC's Finance committee in March to enable procurement. This has been re-timed and June is targeted to enable further clarity on the acquisition of the Factory Shop.
- 7.2.2 Pre-app submission is being prepared based on full market square option. Submission date to be confirmed.
- 7.2.3 The parking strategy is needed ahead of the Traffic Regulation Order
- 7.2.4 Tree Strategy is required and Stakeholders have been engaged with regarding locations for mitigation planting.
- 7.2.5 A separate paper is provided which provides an update on the status of the Precinct.

## 7.3 Sport Hub

- 7.3.1 The Sport Hub project is made up of four sub-projects. These are the development of: a new Sports Pavilion, a new 3G pitch, and a grants for facility improvement to the Rugby Club and the Football Club respectively.
- 7.3.2 The 3G pitch and Sport Pavilion projects have been paused and form part of the second phase of projects and a review of these projects has begun.

## 7.4 Oxley Park (Phase 2)

7.4.1 The project's central focus is on creating a new skate park facility in Oxley Park, along with drainage adaptation, screening and better stepped access & walkways and this project is underway and on track

#### 7.5 Trails and Activities at Underbank

7.5.1 This project has been paused and forms part of the second phase of projects and a review of these projects has been recommended to Board. Some work led by Yorkshire water on costs and options is expected to take place and will be supported in the interim.

#### 7.6 Hopper Bus

7.6.1 The project seeks to establish, via providing pump priming, a sustainable, community-led, responsive bus service which can provide links across the community to places of work, education, healthcare and leisure which are under-served. Expression of Interest (EoI) for the grant funding is now available on the website and the community transport sector will be proactively engaged and briefed on this opportunity.

#### 7.7 Post 16 Hub

7.7.1 The scope of the project focuses on the development of a Skills and Education offer, delivered from the Community Hub building. The funding is ring-fenced and it is expected it will be utilised to grant fund an education provider once the building is operational (expected March 2025). A high-level MoU with Northern College has been agreed which confirms the funding intention and allow Northern College to start business planning for 2025.
