NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- No Waiting Monday to Friday 07.00 to 19.00 on parts of Cross Gilpin Street;
- Paid for Parking Spaces Monday to Saturday 08.00 to 18.30 on parts of South Street.

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For preserving or improving the amenities of the area through which the road runs

Explanatory Notes:-

South Street

The proposed Paid for Parking Spaces Monday to Saturday 8.00 to 18.30 are required to provide short stay parking spaces as part of a housing refurbishment project.

Cross Gilpin Street

The proposed no waiting Monday to Friday 7.00 – 19.00 is required to facilitate the movement of traffic and improve access to business premises.
