The effect of the Order will be to introduce:

- Prohibited left-hand turn except for pedal cycles on part of Rockingham Lane;
- Prescribed right-hand turn except for tramcars on part of West Street;
- Prohibition of Driving except for Pedal Cycles on parts of Carver Street and Wellington Street:
- One Way Traffic (with pedal cycle exemption) on parts of Division Street, Carver Street and Wellington Street;
- One Way Traffic on Backfields and Backfields to Carver Street Link Road;

And remove:

 One Way Traffic on parts of Backfields, Backfields to Carver Street Link Road and Carver Street:
