Job Purpose

To ensure the safe crossing of pedestrians, including children for a specified period in the morning and afternoon, across designated roads on their journey to and from school

Duties and Responsibilities

Control large groups of children wishing to cross the road, ensuring their safety, including:

- I) Instructing children to wait on the pavement before crossing.
- ii) Authorising children to proceed across the road.
- iii) Ensure that traffic does not proceed until all children have safely crossed the road.
- iv) Ensure health/safety codes of practice are adhered to at all times.
- 2. Anticipate the actions of problematic children.
- 3. Report motorists where necessary to the School Crossing Supervisor.
- 4. Report any accidents, and act as witness for the police if necessary.
- 5. Report any children who misbehave to the appropriate Headteacher.
- 6. Identify any hazard close to the crossing point, and report to the Supervisor, as necessary.
- 7. Ensure that the full uniform is worn at all times when on duty.
- 8. Ensure the cleanliness of uniform and crossing pole.
- 9. Inform your supervisor when flashing lights are not working.
- 10. To cover other School Crossing locations within the immediate vicinity, as and when required.
