NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to introduce/add:

- Prohibited Right Hand Turn on part of Rustlings Road;
- With flow bus lanes at all time on parts of Abbeydale Road;
- With flow bus lanes 7:30am to 9:30am Monday to Friday on part of Moore Street;
- With flow bus lanes 4:00pm to 6:30pm Monday to Friday on part of Moore Street;
- No waiting at any time on parts of Abbeydale Road, Abbeydale Road South, Ecclesall Road, Hutchinson Road, Knaresborough Road, Rustlings Road and Sherwood Glen;
- No waiting Monday to Saturday 7:30am-18:30pm on parts of Abbeydale Road;
- No loading at any time on parts of Abbeydale Road and Bannerdale Road;
- No loading Monday to Friday 7:30am-9:30am and 16:00pm 18:30pm on parts of Abbeydale Road, Abbeydale Road South, Ecclesall Road, Hutchinson Road and Sherwood Glen;
- 24 hour Disabled bay on part of Abbeydale Road;

And remove:

- With flow bus lanes 7:30am to 9:30am Monday to Friday on parts of Abbeydale Road, Abbeydale Road South and Ecclesall Road,
- With flow bus lanes 4:00pm to 6:30pm Monday to Friday on parts of Abbeydale Road and Ecclesall Road,
- Limited waiting Free Parking Place Monday to Saturday 7:30am 18:30pm max stay 1 hour no return within 3 hours on part of Abbeydale Road;
- No waiting 8:00am-18:30pm on parts of Abbeydale Road South and Sherwood Glen;
- No waiting Monday to Friday 7:30am-9:30am and 16:00pm-18:30pm on parts of Abbeydale Road and Abbeydale Road South;
- No waiting Monday to Friday 7:30am-9:30am on parts of Abbeydale Road South;
- No waiting Monday to Friday 7:30am-18:30pm on parts of Abbeydale Road;
- No loading Monday to Friday 7:30am-9:30am and 16:00pm-18:30pm on parts of Abbeydale Road;
- No loading Monday to Friday 7:30am-9:30am on parts of Abbeydale Road South;
- No loading Monday to Friday 8:00am-9:30am and 14:30pm 16:00pm on parts of Bannerdale Road

## THE SHEFFIELD CITY COUNCIL (RUSTLINGS ROAD/ECCLESALL ROAD) (PROHIBITED RIGHT TURN) ORDER 2024

Connecting Sheffield: Abbeydale Road and Ecclesall Road is a public transport infrastructure project which is part of Connecting Sheffield – an approach designed to transform travel in Sheffield, making the city a more attractive place to live, work and spend time.

The scheme will provide more consistent public transport journey times between the city centre and the South West areas of Sheffield and more consistent journey times for people who use the bus to get to work, increasing productivity for businesses. Making public transport a more attractive option by giving buses more priority.

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- To facilitate the free and safe flow of traffic
- For improving the amenities of the area through which the road runs

Explanatory Notes:-

#### Bus Lane Extension (Ecclesall Road on approach to Moore Street roundabout) -

The proposed extension of the peak hour bus lane (7.30am-9.30am and 16.00pm – 18.30pm) compliments a new highway layout, which incorporates a bus pre-signal on approach to Moore Street roundabout. This will prioritise bus movements at this location over general traffic and will contribute towards a more consistent journey time for buses on what is an important route into the City Centre.

#### Rustlings Road / Ecclesall Road (Proposed Waiting Restrictions) -

The proposed waiting restrictions will aid pedestrian visibility at new and existing pedestrian crossing locations. Amendments to waiting restrictions on Ecclesall Road between Rustlings Road and Hunters Bar will compliment the new bus stop location.

# Ecclesall Road (Proposed Removal of Bus Lane, outbound from Hunters Bar to Rustlings Road) –

The proposed removal of a short section of bus lane will aid the flow of traffic (outbound from the City Centre at Hunters Bar) which subsequently also supports a more consistent bus journey time outbound from the City Centre.

**Abbeydale Road South / Abbey Lane junction (Proposed Waiting Restrictions)** – Waiting restrictions proposed between Sherwood Glen and Abbey Lane will aid the flow of traffic during peak times and contribute to consistent bus journey times on an important public transport route to the City Centre.

Abbeydale Road South / Abbey Lane junction (Proposed Removal of a short section of bus lane on approach to the Abbey Lane junction) – The removal of a short section of bus lane will assist with traffic flows on approach to the Abbey Lane junction and subsequently also support a more consistent bus journey time.

Abbeydale Road on approach to the junction with Springfield Road (Proposed removal of a short section of bus lane) and addition of 'no waiting at any time' restrictions – The changes aid traffic flows on approach to the Springfield Road junction which in turn will assist with a more consistent bus journey time along the whole corridor.

Abbeydale Road, junction with Springfield Road to Hutchinson Lane – Proposed changes to waiting restrictions will compliment bus stop amendments, add accessible parking and improve access for deliveries to Hutchinson Road. The changes will also aid movement of general traffic at peak times through the Springfield Road / Archer Lane junction which will subsequently also aid the movement of buses.

Hutchinson Lane to Bannerdale Road, proposed 24 hour bus Lane – The proposed change will allow buses to bypass the Tesco access junction, improving bus journey times into the City Centre.

**Hutchinson Lane to Bannerdale Road, Proposed no waiting, no loading at any time –** The proposed changes will compliment the proposed 24 hour bus lane in this location which will improve the consistency of bus journey times (inbound to the City Centre).

**Proposed 'no waiting at any time' restrictions between Archer Road / Bannerdale Road and Troutbeck Road –** The proposed waiting restrictions will allow appropriate lane widths to be provided on approach to the Bannerdale Road junction, aiding the safe movement of traffic and contributing to a more consistent journey time for buses in and out of the City Centre.

- 2. Save as provided in Article 3 of this Order no person shall cause or permit a vehicle which is proceeding in an easterly direction on Rustlings Road to make a right hand turn from its northerly junction with Ecclesall Road, into Ecclesall Road.
