The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs

Explanatory Notes:-

Stalker Lees Road

The proposed removal of Paid for Parking Places max stay 4 hours and Permit Holders Parking Places Monday to Saturday 8.00 to 18.30 are required to provide access to a new housing development. The proposed Paid for Parking Places max stay 4 hours and Permit Holders Parking Places Monday to Saturday 8.00 to 18.30 and the removal of no waiting at any time restrictions are to provide further parking opportunities for residents and visitors in the area to counteract any parking space losses.

Cemetery Avenue

The proposed removal of Paid for Parking Places max stay 2 hours and Permit Holders Parking Places Monday to Saturday 8.00 to 18.30 will provide space for the proposed Disabled Persons' Badge Holders Parking Places max stay 4 hours. These Parking Places will provide a dedicated facility for disabled visitors to the Cemetery and surrounding area close to the Cemetery entrance. The proposed No Waiting at any Time restriction is required to facilitate the movement of traffic and enable access to the Disabled Persons' Badge Holders Parking Places in the newly refurbished area.
