#### And remove:

- No Waiting at Any Time on parts of Sheffield Road (Tinsley);
- Limited Waiting free parking place 8:00am to 6:30pm, maximum stay 1 hour no return within 4 hours on parts of Sheffield Road (Tinsley);
- Prohibited right hand turn on part of Sheffield Road (Tinsley):

#### STATEMENT OF REASONS

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs

#### **Explanatory Notes:-**

The proposed extension of the 24 Hour clearway - no stopping at any time restriction on Sheffield Road (Tinsley) and removal of No Waiting At Any Time and limited waiting Free Parking Places helps to prioritise active travel by keeping the proposed cycle lanes free of parked or loading vehicles.

The proposed banned right hand turn from Ferrars Road to Sheffield Road and banned U Turn through the Sheffield Road central refuge gap opposite Ferras Road will prioritise the right turn movement from Sheffield Road to Ferras Road, whilst other traffic is directed around the gyratory to reach its destination of which requires the removal of the existing prohibited right hand turn into the link opposite St Lawrence Road.

The prohibition of driving from Ferrars Road into Sheffield Road – Service Road will simplify the junction of Ferrars Road to make it safer for cyclists travelling on Sheffield Road. This will reduce the amount of turning movements in and around Ferrars Road crossing for cyclists.

The one-way traffic/no entry restriction at the central refuge gap between Sheffield Road (Service Road) and Sheffield Road will prioritise traffic entering the Service Road at that junction and direct traffic leaving the Service Road via St Lawrence Road.
