THE SHEFFIELD CITY COUNCIL (STOPPING RESTRICTIONS, WAITING RESTRICTIONS, LOADING RESTRICTIONS & PARKING PLACES) (MAP SCHEDULE) ORDER 2024 (AMENDMENT NO. *) ORDER 2024

NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to introduce:

- No waiting at any time on parts of Gibraltar Street, Paradise Street and Silver Street;
- Paid-for parking place 8:00am-8:30pm on parts of Silver Street;
- Loading place on part of Westbar Green;

And remove:

- No waiting at any time on parts of Paradise Street;
- No waiting 8:00am-8:30pm on parts of Paradise Street and Silver Street;
- Paid-for parking places 8:00am-8:30pm on parts of Gibraltar Street, Paradise Street and Silver Street;

STATEMENT OF REASONS

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs

Explanatory Notes:-

Proposed No Waiting At Any Time on Gibraltar Street, Paradise Street and Silver Street – This is to facilitate the movement of large vehicles and allow servicing to frontages.

Proposed removal of Paid-for Parking Places on Paradise Street and Gibraltar Street – This is to facilitate the movement and access of large vehicles and allow servicing to frontages.

Proposed Paid-for Parking Place on Silver Street – The proposed parking places will replace the parking provision removed from Paradise Street.

Proposed Loading Place on West Bar Green – To facilitate servicing to frontages and the pickup and set down of passengers.
