   Eyre Street, Furnival Square and High Street;
- Prescribed right hand turn on part of Norfolk Street;
- No waiting at any time on parts of Charles Street, Norfolk Street Unnamed Access Road to

Arundel Gate Car Park, Pinstone Street and Surrey Street;

- No Loading at any time on parts of Cambridge Street, Charles Street, Cross Burgess Street, Division Street, Norfolk Street Unnamed Access Road to Arundel Gate Car Park Pinstone Street and Union Street:
- Disabled Persons' Badge holder parking maximum stay 4 hours no return within 2 hours on parts of Leopold Street, Union Street and Union Lane;
- Loading bay on parts of Charles Street, Pinstone Street and Union Street;
- Loading Place midnight to 6pm on part of Norfolk Street;
- Loading Place midnight to 8am on part of Surrey Street;
- Disabled Persons' badge holder parking place 6pm to midnight on part of Norfolk Street;
- Disabled Persons' badge holder parking place 8am to 6pm maximum stay 4 hours no return within 4 hours on part of Surrey Street;
- Disabled Persons' badge holder parking place 6pm to midnight on part of Surrey Street;

#### And remove:

- With flow bus lanes at all times on parts of Arundel Gate:
- Contraflow bus lanes on part of Charles Street;
- One Way Traffic on the whole or parts of Pinstone Street and Surrey Street;
- No waiting at any time on parts of Leopold Street;
- No loading at any time on part of Pinstone Street and Surrey Street;
- No loading Monday to Saturday 8am to 6:30pm on part of Charles Street, Cross Burgess Street, Pinstone Street and Union Street;
- No loading Monday to Friday 8am to 9:30am and 4pm to 6:30pm on part of Division Street;
- No loading Monday to Saturday 8am to 9:30am and 4:30pm to 6:30pm on part of Leopold Street;
- Loading Place on parts of Pinstone Street, Surrey Street and Union Street;
- Paid-for Parking Place 8am to 8:30pm on parts of Charles Street, Surrey Street, Union lane and Union Street;
- Disabled Persons' badge holder parking place on part of Charles Street, Pinstone Street and Union Street
- Loading Place Monday to Saturday 8am to 6:30pm on part of Norfolk Street and Surrey Street:
- Taxi bay, no waiting except for taxis 6:30pm to 8am, on part of Surrey Street;

## STATEMENT OF REASONS

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs, or
- For preserving the character of the road in a case where it is specially suitable for use by persons on foot, or pedal cycle, or
- For the management of the air quality

## **Explanatory Notes:-**

Connecting Sheffield: City Centre is an ambitious scheme to improve the city centre environment. We're making it a more attractive place to live, work, and spend time. It's part of the transformation of Sheffield's City Centre to become a vibrant, dynamic commercial hub. More people are living and working in the city centre, so our transport infrastructure and public spaces need to be developed to enable people to access work, education and leisure opportunities.

The city centre scheme proposals will create new green spaces and build on the opportunities for people to walk, wheel (wheelchairs, pushchairs, mobility scooters), cycle and travel by bus

across the city centre.

The project will:

- create open, attractive places and spaces in the city centre where people want to stop, relax and spend time.
- Reduce bus journey times across the city centre and improve reliability, making the bus a
  more attractive choice for people visiting the city centre.

The Sheffield City Council in exercise of its powers under Section 1(1) and (2), 2(1) to 2(4), 4(2) and Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into operation on the th day of ..., 2024 and may be cited as "The Sheffield City Council (City Centre) (Weight Restrictions) Order 2024".

## 2. Definitions

In this Order:-

"Heavy Commercial Vehicle" has the same meaning as in Section 138 of the Act.

### 3. Prohibition Of Heavy Commercial Vehicles

Save as provided in Article 4 of this Order, no heavy commercial vehicle of over 7.5 tonnes gross vehicle weight shall, except upon the direction or with the permission of a police constable in uniform, proceed in any of the roads or lengths of roads specified in the Schedule to this Order.

## 4. Prohibition Of Heavy Commercial Vehicles – Exemptions

- (1) Nothing in Article 3 of this Order shall make it unlawful for any heavy commercial vehicle to proceed in any of the roads or lengths of roads specified in the Schedule to this Order if the vehicle is being used:-
  - (a) to proceed to or from premises situated within that length of restriction for the purpose of loading and/or unloading.
  - (b) in connection with the carrying out on, or on premises situated on or adjacent to any of the roads or length of roads of any of the following operations:-
    - (i) building, industrial, or demolition operations;
    - (ii) the removal of obstructions to traffic:
    - (iii) the maintenance, improvement or reconstruction of the roads or lengths of road;
    - (iv) the laying, erection, alteration or repair in or on land adjacent to any of the roads or lengths of roads of any sewer or any main pipe or apparatus for the supply of

water gas or electricity or any telegraphic line as defined in the Telegraph Act 1878;

- (c) for the fire brigade, police or ambulance purposes;
- (d) in the service of a local authority or water authority in pursuance of statutory powers or duties.
- (2) Nothing in Article 3 of this Order shall make it unlawful for any bus to proceed in any of the roads or lengths of roads specified in the Schedule to this Order.

The Sheffield City Council ("the Council") in exercise of its powers under Section 1(1), 2(1) to (3), 4 (2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124 (1) (c) (d)and (f) of the Road Traffic Regulation Act 1984 (c.27) ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order shall come into operation on the , 2024 and may be cited as The Sheffield City Council (City Centre) (Prohibition of Motor Vehicles) Order 2024.

#### **Definitions**

In this Order:-

"Permit" means a permit issued by the Council and used in a manner directed by the Council.

"Road" has the same meaning as that in section 142 of the Act.

- "Traffic Sign" means a sign or marking of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the Act.
- 2. Save as provided in Articles 3, 4 and 5, no person shall cause or permit any motor vehicle, except upon the direction of with the consent of a police constable in uniform, to proceed in those areas of Road set out in Schedules 1 and 2 to this Order.
- 3. Nothing in Article 2, shall render it unlawful for any vehicle to proceed in that area of Road included in Schedules 1 and 2 to this Order if:-
  - (a) for so long as may be necessary to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely –
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said road; and
    - (iv) the laying, erection, alteration or repair in or on land adjacent to the said road of any sewer or of any main, pipe, line or apparatus for the supply of gas, water or electricity or of any line which is, or forms part of electronic communications apparatus as defined in the Communications Act 2003:
  - (b) the vehicle is being used in an emergency for ambulance, fire brigade, police or local authority purposes.

- 4. Nothing in Article 2 or 3 shall render it unlawful for any motor vehicle to proceed in that area of Road included within Schedule 2 to this Order if:-
  - (a) that vehicle has been granted a special authorisation by Sheffield City Council exempting that vehicle from its provisions, subject to compliance at all times with the terms and conditions of the said special authorisation.
  - (b) it is an official vehicle approved for use in wedding or funeral ceremonies by its organisers;
- 5. Nothing in Article 2 or 3 shall render it unlawful for any motor vehicle to proceed in the Roads referred to in Schedule 2 therein between midnight to 10.00 a.m. and 6.00 p.m to midnight, if:
  - i) that vehicle is taking access for the purposes of loading or unloading at premises; and
  - ii) the Council has not authorised the carrying out of a sporting event, social event or entertainment on the Roads; and access has not been restricted for those purposes, said restriction being indicated by the display of Traffic Signs at such times as authorised by the City Council for reasons of public safety prior to, during and after those events.
