Highways Act 1980 – Section 116

Permanent Closure of Parts of Starling Mead and Partridge View, Skye Edge, Sheffield 2.

Following successful completion of the legal processes, I can confirm on behalf of the Highway Authority that the above legal order has been fully implemented.

HIGHWAYS ACT 1980 - SECTION 116

BEFORE the Magistrates' Court sitting at Castle Street in and for the Sheffield Metropolitan District.

APPLICATION having been made under Section 116 of the Highways Act 1980 that:-

1. An irregular area of all-purpose highway at the southernmost point of Starling Mead as shown hatched on the Order plan, commencing at a point shown as A on the Order Plan, that point being at grid reference 436993:386723 approximately 38 metres southwest of the junction with Skye Edge Avenue, heading in a south-westerly direction for approximately 6 metres with a maximum width of 0.9 metres to a point shown as B on the Order plan, that point being at grid reference 436998:386720 then heading in a generally northeasterly direction for approximately 7 metres, with a maximum width of 1.4 metres to a point shown as C on the Order plan, that point being at grid reference 437003:386723.
2. An irregular area of all-purpose highway forming part of the grass verge of Starling Mead as shown hatched on the Order plan, commencing on the eastern side at a point shown as D on the Order plan, point D being at grid reference 437005:386734 approximately 22 metres southwest of the junction with Skye Edge Avenue, heading in a southeasterly direction for approximately 5.5 metres with a maximum width of 4.8 metres to a point shown as point E on the Order plan, that point being at grid reference 437009:386732.
3. An irregular area of all-purpose highway forming part of the grass verge on the eastern side of Partridge View as shown hatched on the Order plan, commencing at a point shown as F on the Order plan 39 metres southwest of its junction with Skye Edge Avenue, point F being at grid reference 437057:386687, heading in a southeasterly direction for 3.5 metres with a maximum width of 5.3 metres to a point shown as G on the Order plan, that point being at grid reference 437061:386685.

As shown hatched black on the Plan annexed hereto, should be stopped up on the ground that they are unnecessary.

AND the Court being satisfied that the Applicant has given the Notices required by Part I of the Twelfth Schedule to the Highways Act 1980.

AND the Court having heard the Application.

AND the Court being satisfied that the said area of highway is unnecessary.

IT IS HEREBY ORDERED that the said areas of highway be authorised to be stopped up for the purposes of all traffic.

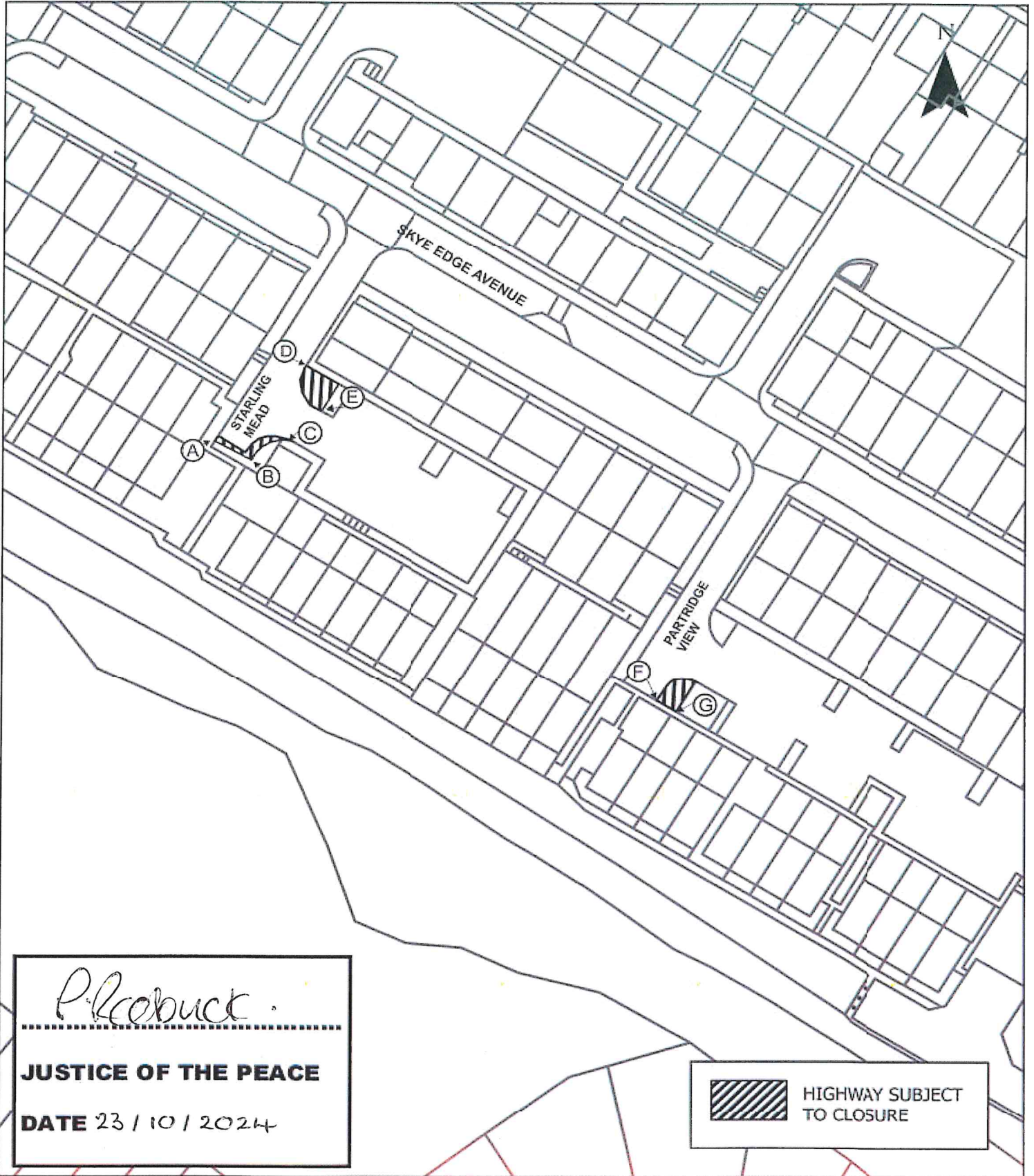
