Notice is hereby given that Sheffield City Council in exercise of its powers and having consulted with the Chief of Police under Section 23 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers propose to install a pedestrian crossing as listed below:

**1 Puffin Pedestrian Crossing** on **Glossop Road** – 51 metres east of its junction with the north eastern kerb line of Durham Road. The extent of the crossing and its zig zag 'no stopping' lines extend from a point 27 metres east of its junction with the north eastern kerb line of Durham Road for a distance of 46 metres in an easterly direction.



# STATEMENT OF REASONS

The Authority's reasons for proposing to make the above-named Order(s) are as follows: -

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- For preserving or improving the amenities of the area through which the road runs

# Explanatory Notes: -

Glossop Road – The proposed removal of the Taxi Stopping Area (no stopping except Taxis) is required to accommodate the required length of zig-zags that support the new proposed signalised pedestrian crossing on Glossop Road between Durham Road and Leavy Greave. The new pedestrian crossing is aimed at improving visibility and road safety of the users of the pedestrian crossing, drivers and cyclists. There is currently no existing pedestrian crossing facility on this section of Glossop Road to provide safer walking routes for the high pedestrian footfall predominantly from the University campuses close by. This includes the Student Union bar which is within metres of the proposed crossing facility.

The proposed new Taxi Stopping Area (no waiting except Taxis) is to accommodate a shorter length of Taxi Stopping Area on this part of Glossop Road.

The proposed no waiting at any time and no loading 7.30-9.30am and 4-6.30pm and removal of no waiting and no loading at any time is to update the Traffic Regulation Order to formalise the current restrictions on street.
