Request to Advertise

Information Notes

A hackney carriage vehicle proprietor (under hackney carriage bylaws) may request from the Council consent to advertise on the exterior of their vehicle.

The vehicle proprietor shall provide to the Council such details of the proposed advertisement as the Council may reasonably require in order to determine that the proposed advertisement:

- will not adversely affect the safety of the vehicle;
- will not adversely affect the appearance of the vehicle; and
- not cause offence

The proprietor shall also supply a copy of the draft contract to advertise.

Please note the Council reserves the right not to approve advertisements for any goods and services in relation to tobacco and/or alcohol or are sexual and/or religious in nature etc...

The contract to advertise must comply with the following requirements:

- one of the parties to the contract must be the holder of the vehicle licence which is the subject of the contract;
- the contract must have the facility to state the vehicle details and the termination of the contract; and
- the contract must contain a condition that the advertisement must be removed at the end of the contract term.

The Licensing Sub-Committee has delegated authority to Officers of the Council to grant consents to advertise where the proposed advertisements satisfies the criteria set out above.

Should an approved advertisement come to be in such a condition that, in the opinion of an Authorised Officer of the Council, it adversely affects the safety of the appearance of the vehicle then the vehicle licence will be suspended with immediate effect.
