NOTICE IS HEREBY GIVEN that the Sheffield City Council proposes to make an Order under the provisions of Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 46A, 49, 51, 53 and 124(1)(c), (d) (f) and Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to introduce:

- No Stopping At Any Time On Verge Or Footway on parts of Broad Lane, Corporation Street, Garden Street, Hollis Croft, Queen Street, Scotland Street, Solly Street, Tenter Street, West Bar, West Bar Green and White Croft

STATEMENT OF REASONS

The Authority's reasons for proposing to make the above named Order(s) are as follows:-

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).
- For preserving or improving the amenities of the area through which the road runs
- For preventing damage to the footpath and/or verge near the road

Explanatory Note:-

The proposed No Stopping At Any Time On Verge Or Footway restrictions will remove obstructing vehicles from the footpaths and verges, providing safer facilities for pedestrians and cyclists. The restrictions will also protect the verge and footway from damage caused by vehicles mounting the kerb and stopping on these routes intended for pedestrians and cyclists only.
